Mustera Property Group Ltd (**Mustera** or the **Company**) is pleased to provide an update on its operational activities during the September 2024 Quarter (the **Quarter**).

HIGHLIGHTS

1. The Group continued to market the remaining apartments and commercial units for sale in its Forbes Residences project.
2. The Group commenced with the schematic design and preparation of the marketing collateral for its McCabe Street project with a target launch in Q1 2025.

1. Forbes Residences, 10 Forbes Road, Applecross

The Group continued to market the remaining 5 unsold apartments and 4 commercial lots in the project during the quarter.

There has been strong interest from potential buyers and one apartment is under contract at the end of the quarter.

The Group intends on scaling up a focused marketing campaign in Q4 2024 to sell the unsold apartments and commercial units.

2. 15 McCabe Street, North Fremantle

During the quarter the Group commenced with the schematic design of its 42 apartment, 8 storey, McCabe Street project which overlooks the Swan River and Indian ocean.

The consultant team worked in parallel with the marketing agency to progress with the architectural and interior design of the project, with a strong focus on quality and efficiency, and progress a suite of marketing collateral with a target launch in Q1 2025.

3. Comments on Financials

In accordance with Listing Rule 4.7C.1, the Company spent approx. \$0.4 million during the quarter on operating costs, associated with the ongoing development work on its portfolio.

The Company incurred interest and finance costs of approx. \$195K during the quarter. Additionally, operational overheads totalling \$364K for the quarter comprise staff costs of \$111K and administrative and corporate costs of \$253K.
