Extension of time to dispatch Annual Report

Capitol Health Limited ACN 117 391 812 (ASX: CAJ) (**Capitol**) refers to the proposed merger with Integral Diagnostics Limited ACN 130 832 816 (ASX: IDX) (**IDX**) by way of a scheme of arrangement (**Scheme**).

Further, Capitol refers to its announcement of 26 September 2024 in which it was noted that Capitol had lodged an application with the Australian Securities and Investments Commission (ASIC) requesting an extension of the period of time for dispatch of Capitol's 2024 Annual Report.

Capitol announces that ASIC has formally granted Capitol an extension of the period of time for dispatch of Capitol's 2024 Annual Report, which was released to the ASX on 22 August 2024, until the earlier of 21 days before Capitol's next Annual General Meeting after the financial year ended 30 June 2024 (AGM) (pursuant to the extension granted as set out Capitol's ASX announcement of 26 September 2024) or 31 January 2025.

As a result of the extensions granted by ASIC and given the Scheme is expected to be implemented on 16 December 2024 (subject to all necessary approvals from the Court and any relevant government agency), Capitol does not expect to hold an AGM for 2024, or to dispatch its 2024 Annual Report to its shareholders, unless the Scheme is significantly delayed beyond the current timetable. Capitol will announce any changes to the timetable to the ASX.
