^{**}The outstanding number or VEU as of 31 January 2025 should have been 38,202,578. The announcement on 7 February 2025 had this number as 38,187,578, which had incorrectly omitted an issuance of 15,000 of VEU created on 28 January 2025. The outstanding balance of 38,249,578 as at 28 February 2025 has accounted for the corrected opening balance of 38,202,578.



^ The ETF Securities Outstanding (US) refers to the ETF securities issued by The Vanguard Group, Inc. in the US and is inclusive of the CDIs that are issued in Australia.
